Having consulted the medical file on the above-mentioned inmate, we wish to inform you of the following:

The inmate was examined when he arrived in the prison on 19 April 2016. The results of the examination were within normal limits except for the inmate's claim that he suffers from chronic headaches (migraine). All the laboratory and X-ray tests conducted produced results that were within normal limits.

He was presented to a psychiatrist on 20 April 2016 and underwent a clinical psychological assessment on 24 April 2016. He was found to be in good health and not to require psychiatric treatment.

The inmate claims to have been on hunger strike since 20 April 2016. He has undergone regular examinations of the kind normally conducted in such cases. In fact, the inmate consumes water and juices in the presence of the nursing and medical staff and his vital signs are normal.

The patient is regularly monitored by the prison doctors, therapists, psychiatrists and nursing staff (three times a day) except when the inmate refuses to attend the clinic.

Kindly take whatever action is deemed necessary in light of the foregoing.

Please find attached herewith the following listed documents that substantiate the above-mentioned replies of the State of Kuwait on your queries in this regard:

- 1- A medical certificate issued by the Ministry of Health concerning the state of health of the prisoner Abdelhakim Abdelrazzak Abdelhadi Shabth, refuting the allegations contained in your above-mentioned letter in this regard.
- 2- A copy of a certificate issued by the Permissions and Visits Division of the Ministry of Interior, stating that visits of relatives do not require identity cards delivered by the Central Agency for Remedying Illegal Residents' Status. Indeed, the attached certificate shows that the brother of the prisoner Abdelhakim, Mr. Abdelhadi Abdelrazzak Shabth, has been able to visit his brother by simply producing his driving license, and not an identity card delivered by the Central Agency for Remedying Illegal Residents'

We would also like to reconfirm that a more detailed and exhaustive reply on the queries contained in your letter will be forwarded to your attention as soon as we receive it.



بالإطلاع على الملف الطبي للنزيل المذكور أعلاه نفيدكم بما يلي:
تم فحص النزيل عند دخول السجن يوم 2016/4/19 و كانت نتيجة الفحص ضمن الحدود الطبيعية عدا ادعاء النزيل بأنه يعاني من صداع مزمن (شقيقة) علماً أنه تم إجراء الفحوص المخبرية و الشعاعية و كانت كلها ضمن الحدود الطبيعية.
تم عرض النزيل على الطب النفسي بتاريخ 2016/4/20 و تم عمل تقييم نفسي اكلينيكي بتاريخ 2016/4/24 و تبين أنه سليم و لا يحتاج للعلاج النفسي.
من تاريخ 2016/4/20 و حتى اليوم ادعى النزيل اضرابه عن الطعام و تم متابعته بالفحوصات الدورية و المتبعة في مثل هذه الحالات، علماً أن النزيل يتناول الماء و العصائر بصورة طبيعية أمام الهيئة التمريضية و الطبية و العلامات الحيوية له سليمة.
المريض يتابع حالياً من قبل أطباء السجن و المعالجين و الأطباء النفسيين و الهيئة التمريضية بصورة دورية (ثلاث مرات يومياً) عدا الحالات التي يرفض فيها النزيل الحضور إلى العيادة.
