With regard to the communication No UA IRN 20/2016 Dated 1 July 2016, concerning Ms. Nazanin Zaghari, the following information has been provided by the "High Council for Human Rights of the Judiciary of the I.R. of Iran":

Ms. Nazanin Zaghari was arrested by order of judicial authorities in Tehran airport after finding well-founded evidence indicating her action against national security. After dispatching her to Kerman (the place where crime was discovered), investigations regarding her accusations were initiated.

During her detention, she was in a suite in Kerman prison and had frequently telephonic contacts and visitations with her family. Taking into account humanitarian considerations (considering her motherhood and the best of interests of her child), Ms. Zaghari was transferred to Tehran where she was provided with daily meetings with her child.

It should be added that according to State rules, Ms. Zaghari is considered as an Iranian citizen and her additional citizenship is not recognized. Her husband can receive latest information about her dossier, by referring to the Consulate section of the Embassy of the Islamic Republic of Iran in London. Although at the moment he has the latest information about his wife through contacts with Ms. Zaghari's family members in Iran who have regular visitation with her. He can even travel to Iran.

With regard to her health condition, it is worth mentioning that she is in good health condition in prison.

Regarding the claim for not having access to a lawyer, it should be noted that according to the law, the access to a lawyer for security crimes offenders is envisaged and based on legal conditions reflected in the law, it will be provided upon the request of defendants.

It should be noted that due to the importance of the accusations, the case is under investigations and consequently, after completion of the investigations, the indictment will be announced containing the list of her charges.

Other allegations regarding the aforementioned person are hereby refuted.
