- 1- Representatives from the Department of citizenship and documentation.
- 2- The national human rights Committee.
- 3- Office of Legal Affairs of the Ministry of the Interior.
- 4- Department of human rights of the Ministry of the Interior.
- 5- Department of human rights of the Ministry of Foreign Affairs.

*To study the recommendations related to the above-mentioned subject, and to make appropriate proposals on possible amendment of the nationality law, especially that the State of Qatar has supported these recommendation".*

The Permanent Mission of the State of Qatar avails itself of this opportunity to renew to the Special Procedures Branch (HRCSPD), Office of the High Commissioner for Human Rights (OHCHR) in Geneva , the assurances of its highest consideration.
