

1. The person concerned is bound by public prosecution no. ■■■ of 2014 international cooperation petitions, and has been detained pending investigations in case no. ■■■■ of 2012 (first directorate Madinet Nasr), after being arrested during the break-up of the occupation of Rabaa al-Adaweya Square, when he was involved in opposing the police forces tasked with breaking up the occupation, using a firearm, which led to the death and wounding of several members of the security forces.
2. The prosecution has directed several accusations against him on the basis of the statements of several witnesses of the incident. The case is still in the investigation stage, and 3 June 2014 is the date set for the felonies court to examine the renewal of his detention.
3. The prosecution was informed by the family of the accused that he was on hunger strike, and the prisons sector was officially informed of this. Accordingly, he was asked by one of the prison officers to decide to end his hunger strike voluntarily out of concern for his health.
4. On 2 June 2014, the prosecution issued a decision appointing a medical committee, chaired by the head of the medical department of the prisons authority and one of his assistants, to carry out a medical examination of him and report on his state of health and whether or not he needed hospital treatment outside the prison.



- ١- أن المذكور مفيد لدى النيابة العامة برقم [] لسنة ٢٠١٤ عرائض تعاون دولي، وهو مجسوس إحتياطياً على ذمة القضية رقم [] لسنة ٢٠١٢، بإدري مدينة نصر أول، إذ تم ضبطه أثناء فض اعتصام رابعة العنوية حال مشاركته في مقاومة قوات الشرطة المكلفة بفض الاعتصام مستخدماً سلاحاً تارياً مما أدى إلى وفاة وإصابة العديد من قوات الأمن.

- ٣- تم إخطار النيابة العامة من قبل أهلية المتهم المذكور بأنه مضرب عن الطعام والشراب، وتمت مخاطبة قطاع السجون رسمياً بذلك، وعليه تم سؤاله بمعرفة أحد الضباط بالسجن وقرر التراجع مختاراً عن الإضراب عن الطعام والشراب حرصاً منه على صحته.
- ٤- صدر قرار من النيابة العامة بتاريخ ٢٠١٤ / ٦ / ٢ بإنتداب لجنة طبية - برئاسة رئيس القسم الطبي بمصلحة السجون وأحد مساعديه- لتوقيع الكشف الطبي عليه وبيان حالته الصحية ومدى إحتياجه للعلاج بمستشفى خارج السجن من عدمه، وذلك تحريراً في ٢٠١٤ / ٦ / ٢
