**Note concerning the human rights report**

All of the accused persons referred to in the above report are suspected of committing offences punishable under the Federal Criminal Code and the Information Technology Act. The Public Prosecution took the decision to place them in preventive detention after questioning them, with full legal safeguards guaranteed.

With respect to Ahmed Mansoor, he was charged with and sentenced for committing offences punishable under the Federal Criminal Code and the Information Technology Act.

The allegations that Ahmed Mansoor's rights were violated in that his defence team was unable to question witnesses are untrue; as substantiated through examination of the case file, the defence team attended all of the investigation hearings conducted by the court, questioned witnesses and put forward his defence and arguments. Concerning his access to a dermatologist, the Public Prosecution confirmed in the case file that it went to the place where the accused was being held in preventive detention, ascertained that the clinic at the facility had a medical file on him, and looked into the treatments he had received. As to the allegation that his relatives were not permitted to attend the hearings, the opposite is true; they attended the hearings and were not prevented from doing so.

### مذكرة فيما ورد بتقرير حقوق الإنسان

بالاطلاع على ما ورد بالتقرير المذكور فإن كل من المتهمين المشار إليهم في التقرير متهمين في جرائم معاقب عليها طبقاً لقانون العقوبات الاتحادي وقانون تقنية المعلومات وصدر قرار من النيابة العامة بحبسهم احتياطياً بعد التحقيق معهم وكفالة كافة الضمانات القانونية .

وإن ما ورد بشأن المدعو / أحمد منصور فإنه اتهم وحكم عليه بارتكابه جرائم معاقب عليها في قانون العقوبات الاتحادي وقانون تقنية المعلومات .

أما بخصوص الادعاءات التي ادعى بها المدعو / أحمد منصور من تعرض حقوقه لانتهاكات في عدم تمكن فريق دفاعه من مناقشة الشهود ، فإن ذلك غير صحيح والثابت من خلال الاطلاع على ملف القضية بأن فريق الدفاع حضر جميع جلسات التحقيق التي أجرتها المحكمة وناقش الشهود وقدم دفاعه ومرافعته أما فيما يخص عرضه على طبيب الجلدية فإن النيابة العامة أثبتت في ملف القضية بأنها انتقلت إلى مكان توقيف المتهم في الحبس الاحتياطي وتأكدت من وجود ملف طبي له في عيادة المنشأة واطلعت على العلاجات اللازمة التي أجريت له وأما فيما يخص عدم السماح لأقاربه في حضور الجلسات فإن الثابت عكس ذلك فإن أقارب المتهم حضروا الجلسات ولم يتم منعهم من الحضور .
