The following information has been provided by the "High Council for Human Rights of the Judiciary of the I.R. of Iran":

"Mr. Mohammad Reza Pourshajari was arrested on 2010 and prosecuted on charges of acting against national security and insulting and defamation of religious sanctities including the Holly Prophet and was sentenced to four years of imprisonment. After serving his four-year jail, he was released in august 2014.

On October 2014, he was arrested and sued again on charges of embarking on propaganda against the Islamic Republic of Iran and futile attempt to illegally leave the country. Hence, a file has been made in the Karaj province court and the accused person is currently being held in Karaj prison custody and waiting for trial. His judicial case is under investigation. It should be notified that after his arrest, a judicial order has been issued based on which, Mr. Pourshajari could be released on bail (in amount of 500 million Rials) until his trial, but due to his failure to provide, he is still in custody.

With regard to his health situation, it should be noted that after expressing his illness, he was dispatched to Shariati hospital in Tehran and was hospitalized for three days; and he was released after being treated. At the moment, his general health condition has been reported satisfactory, and his health condition is under control.

With regard to the alleged arbitrary detention of the said person, it should be said that this allegation is utterly baseless and alleged mental and physical torture and lack of access to medical care is hereby refuted."
