- 1. Mr Amer Kamel ALSHAVA is identified as an individual who is among those who finance the Muslim Brotherhood and involved in investment operations of their funds. The Muslim Brotherhood has been listed as a terrorist organization in the UAE, Egypt, Saudi Arabia and other countries for launching indiscriminate violence against civilians with the aim of spreading terror amongst innocent people through bombings carried out in Egypt and other places.
- 2. On 02/10/2014 at Dubai International Airport, Mr ALSHAVA has been arrested on charges of financing terrorism and was the subject of an arrest warrant issued by the legally competent authorities. Before his arrest, Mr ALSHAVA has been notified of the arrest warrant and the reasons of his arrest have been explained to him. The Turkish Embassy has also been informed about his case.
