Comment by the Egyptian Government on joint communication No. AL EGY 4/2015, dated 13 April 2015, concerning the charges brought against Ms. Azza Soliman

- 1. The law enforcement officers who were present in Talaat Harb Square in central Cairo on 24 January 2015 observed a march by about 50 demonstrators along Qasr al-Nil Street towards Talaat Harb Square, which breached the law concerning the organization of demonstrations. Some participants in the demonstration blocked the street, hurled abusive comments at the armed forces and the police, launched fireworks and clashed with the police, cursing and throwing stones. The law enforcement officers ordered them to halt the demonstration and disperse, but they failed to comply. The law enforcement officers were therefore obliged to intervene, using water cannons and tear gas grenades, and some demonstrators were arrested.
- 2. Notification was received from the Cairo hospital for kidney diseases of the arrival of a young woman called Shaimaa Sabri Ahmed al-Sabbagh, who had been involved in the clashes that had occurred in Talaat Harb Street.
- 3. Against the background of this incident, questions were raised with the Police Commissioner at Qasr al-Nil police station and the Deputy Director of Cairo Security for Abdin Police Department, formerly the Police Services Supervisor. He stated that a number of people had informed him, when he was reviewing the security situation, that almost a thousand demonstrators were marching down Talaat Harb Street and that they were carrying fireworks. So he went along and ordered them to halt the demonstration and to disperse. They ignored the order and began to attack him physically, pushing him backwards. As the demonstration was illegal and the participants were using force in an attempt to storm Talaat Harab Square, he issued instructions to the Central Security Forces to arrest them after firing tear gas from a distance of about 40 metres. Three suspects were arrested.
- 4. Ms. Azza Soliman Hashim testified that when she was in Café Riche she observed a march of about 30 people, including some acquaintances. She went out to meet them and remained with them for a while. When she returned to Café Riche, the police approached the demonstrators, using tear gas and firing gunshots. She added that she had seen the victim Shaimaa al-Sabbagh falling and a young man carrying her to Al-Bustan passage next to the Café.
- 5. A number of press and media correspondents were questioned and reported that there were 30 participants in the demonstration, including the accused, and that they had not perpetrated any hostile acts against the police prior to their dispersal.
- 6. The charges laid against Azza Soliman concern her participation in a demonstration that failed to comply with the rules governing the organization of demonstrations and that breached law and order, which constitutes a misdemeanour under the Act concerning the Right to Public Meetings, Processions and Peaceful Demonstrations. This is what was recorded by the Public Prosecutor's Office in the official misdemeanour case documents, in accordance with articles 4, 7 and 19 of Act No. 107 of 2013 concerning the Right to Public Meetings, Processions and Peaceful Demonstrations. The documents were referred to the court hearing of 4 April 2015 and

the case was discussed at a number of sittings. The most recent was held on 23 May 2015 to deliver the judgement.

7. The court decided to acquit all of the accused, including Azza Soliman Hashim Soliman. The Public Prosecutor's Office appealed against the judgement and the first sitting concerning the appeal was held on 13 June 2015.
