Urgent appeal concerning Mahmoud Mohamed Ahmed Hussein

1. Mahmoud Mohamed Ahmed Hussein was arrested at Al-Salam police checkpoint in Cairo Governorate for possessing 11 Molotov cocktails and 3 locally manufactured explosives as he was on his way to participate in riotous and subversive acts perpetrated by the terrorist Brotherhood organization to mark the third anniversary of the revolt of 25 January 2014.
 2. The Public Prosecutor's Office decided to place him in pretrial detention in connection with El-Marg Police Station Administrative Case No. 715/2014. He was detained in Wadi el-Natrun Prison Complex and his detention was extended in accordance with the legally specific periods.
 3. The signed results of his medical examination in the place of detention showed that he was in good health and was not suffering from any illness or injuries except for the results of surgery previously performed on his sacroiliac joint. There were no indications that he had been subjected to torture.



- ١- المواطن/ محمود محمد أحمد حسين تم ضبطه بكمين شرطة السلام فى محافظة القاهرة وبحوزته ١١ زجاجة مولوتوف و ٣ قنابل محلية الصنع وذلك قبل توجهه للمشاركة فى أعمال الشغب والتخريب التى نفذها تنظيم الإخوان الإرهابى بالتزامن مع الذكرى الثالثة لثورة ٢٥ يناير عام ٢٠١٤.
- ٢- قررت النيابة العامة حبس المذكور احتياطياً على ذمة القضية رقم ٢٠١٤/٧١٥ إدارى قسم شرطة المرج، وإيداعه بمجمع سجون وادى النطرون، ويتم التجديد له فى المواعيد القانونية المحددة لذلك.
- ٣- تم توقيع الكشف الطبى على المذكور بمقر حبسه وتبين أن حالته الصحية جيدة ولا يعانى من أى أمراض أو إصابات بخلاف سابق إجراءه جراحة بمفصل الحوض، ولم يتبين تعرضه للتعذيب.
