## Information on Alexandr Sodiqov case

Alexandr Sodiqov is a citizen of the Republic of Tajikistan, born in Panjakent city of the Sogd region in 1983, was detained by the agents of the State Committee on National Security of Tajikistan in Khorog, Gorno-Badakhshan Autonomous Region (GBAO) on June 16th, 2014. Alexandr Sodiqov nas been incriminated under Art.305 "Treason" of the Criminal Court of the Republic of Tajikistan.

In accordance with the case, Alexandr Sodikov has met with a representative of special services of foreign state and consented to assist in his espionage activities. As a result, he was detained on June 16 in Khorog city in the process of gathering information on the situation in GBAO and the role of the residents of Khorog in destabilizing the situation in the region in recent years.

June 19, 2014, within 72 hours Alexandr Sodikov detained with the decision of the Court of Ismoili Somoni of Dushanbe. The detainee was provided with the lawyer and his family was informed about his detention. June 26, 2014 Alexandr Sodikov has a meeting with his wife -

Since his arrest, lawyer protects the interests of Mr. Alexsandr Sadikov. In addition, since July 3, 2014 relatives of Mr. Sodikov hired 2 more lawyers to protect his interests. In accordance with Article 53 of the Criminal Procedure Code of the Republic of Tajikistan, defenders were fully secured and are able to carry out their legitimate work in a safe and enabling environment without fear of threats or acts of intimidation and harassment of any short.

Alexandr Sodikov currently is in the detention facility of the State Committee on National Security and authorities received no complaints about torture and other cruel, inhuman or degrading treatment or punishment from his side.

Alexandr Sodikov now is under the presumption of innocence, his guilty has not been established, the investigation is going on.
