With regard to the communication No UA IRN 9/2016 Dated 26 April 2016 concerning Mr. Omid Kokabi, the following information has been provided by the "High Council for Human Rights of the Judiciary of the I.R. of Iran":

Mr. Omid Kokabi was sentenced to ten years of imprisonment on charge of cooperation with hostile states after hearing his and his lawyer's defenses and exhausting due process.

Report on his clinical status, from his arrival to the detention center until now, which is received from prisons organization, is as follows:

- His treatment started from May 20, 2011 with his complaint of dental pain, that he referred to a doctor and necessary treatment was conducted. Later, he made other visits to clinic regarding various illnesses and necessary treatments were conducted.
- On May 15, 2011 he referred to the clinic with the complaint of excretion of kidney stones, so a Urology specialist visited him, and SONO was performed for him, then he was again visited by the Urologist and the necessary treatment was conducted for him.
- In 2012, he referred to the clinic with the complaint of stomach pain, and after receiving medicine; he was referred to Internist and treated. Furthermore, with regard to the possibility of suffering from a nervous disease (IBS), a Psychiatric visit was requested for him, but he repeatedly refused.
- On December 30, 2012, he referred to the clinic with the complaint of flank pain and due to his previous kidney stones records, he conducted a UA test which the result was normal, and his treatment was conducted by the doctor.
- On September 17, 2014, his status was provided to the judicial authority by his doctor. Also on February 1, 2015, his clinical status was announced to the judicial authority.
- In October of 2015, he was visited by a doctor due to his complaint of kidney pains.
- Subsequently, after receiving judicial authorization on December 21, 2015, he was sent to Taleghani Hospital and hospitalized in

Gastroenterology division, and after endoscopy and colonoscopy, hemorrhoids was diagnosed, so on January 12, 2016 he was transferred and hospitalized in surgery division.

- During hospital examinations and CT scan, a mass in size of 4 centimeter was seen in his right kidney, and the possibility of angiomyolipoma was raised for him.

- He was discharged from the hospital on March 12, 2016, and after Nowrouz holidays, he was sent again to Shohada Hospital. After MRI and CT scan, the possibility of RCC was raised for him that was transferred to Sina Hospital for further investigations.

Finally, according to the announcement of Tehran Department of Justice, after the conducted investigations and reference of the issue to Forensics Medicine Commission, according to theory dated May 7, 2016 of the mentioned Commission, and order of Tehran Prosecutor, the aforementioned person is outside the prison/ was released from May 25, 2016 with the postponement of the verdict.
