## **Situation of Ms. Hengame SHAHIDI**

The following information has been provided by the High Council for Human Rights of the Judiciary of the Islamic Republic of Iran:

"According to the latest information provided by the Justice Department of Tehran Province, **Ms. Hengame Shahidi** was arrested on the basis of the judicial warrant, on the charges of propaganda against the Islamic Republic of Iran, assembly and collusion with the intend of disturbing internal security of the country. Pursuant to issuing of the arrest warrant, she was introduced to the prison and her file is under investigation. Since there is no final verdict on the case, any expression of view or prejudice is invalid and void. Meanwhile, she has had meetings with her family."

### **Situation of four individuals**

The following information has been provided by the High Council for Human Rights of the Judiciary of the Islamic Republic of Iran:

“According to the information provided by the General Justice Department of Tehran Province,

1. Mr. [REDACTED] was charged with assembly and collusion with the intension of committing crime. He was sentenced to two years of imprisonment. His term of imprisonment shall terminate on 31<sup>st</sup> October, 2017. He enjoys the right of meeting his family and access to telephone.
2. Mr. [REDACTED] was issued with the bill of indictment and is presently in detention in Evin Prison. He enjoys the right of meeting his family and access to telephone.
3. Mr. [REDACTED] is passing his term of imprisonment in Evin Prison. He enjoys the right of meeting his family and access to telephone.
4. Ms. **Tahereh Riyahi** is temporarily in detention in Evin Prison upon the bill of indictment issued by the Culture and Media Prosecutor's Office. She has received visits and phone calls from her family.
