### **Situation of Mr. ALI KAB OMAYR**

The following information has been provided by the High Council for Human Rights of the Judiciary of the Islamic Republic of Iran:

"According to the latest information provided by the Department of Justice of Khuzestan Province, Mr. [REDACTED] not only is not an environment activist, but also he has had cooperation with the terrorist group of Annezalol Arabi. He was arrested on 9. 2. 2017 on the order issued by prosecutor of Ahvaz city. He also confessed to having relations with separatist circles. Mr. [REDACTED] was charged with propaganda activity against the State by branch 12 of public and revolutionary Prosecutor's Office of Ahvaz and since he was not able to provide the bail, he was referred to the prisons organization. Later on 15 March, 2017, on ~~commute~~ of the court decision and introduction of guarantor, he was released.

He is a recognized member a separatist and terrorist group in Ahvaz city and extensive activities under different disguises. His arrest was fully in observation of his rights and there was no harm inflicted on him. Any allegation otherwise, which are made by separatist groups, are unfounded and baseless. Mr. [REDACTED] is in good health out of prison. In spite of his acts against security of the country, the Judiciary practiced affection with him. He was in detention from 2 Feb. to 24 March, 2017 and he is now living with his family until the session of the court. He can introduce his lawyer to the court.

In the course of his detention, all facilities of the prison including medical facilities were available to him similar to other prisoners.
