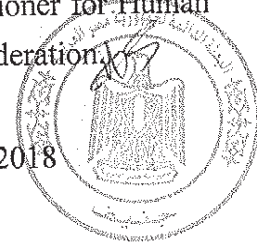

The Permanent Mission of the Arab Republic of Egypt to the United Nations, World Trade Organization, and Other International Organizations in Geneva presents its compliments to the Office of the High Commissioner for Human Rights (Special Procedures Branch); and with reference to the Mission's Note Verbal No. CHAN.2018.040 dated February 14th 2018 that included the response of the Egyptian Government to the Joint Communication sent by the Working Group on Arbitrary Detention; the Special Rapporteur on the promotion and protection of the right to freedom of opinion and expression; the Special Rapporteur on the right of everyone to the enjoyment of the highest attainable standard of physical and mental health; the Special Rapporteur on the situation of human rights defenders; the Special Rapporteur on the rights of indigenous peoples; the Special Rapporteur on minority issues and the Special Rapporteur on contemporary forms of racism, racial discrimination, xenophobia and related intolerance, dated December 11th 2017, concerning alleged arrests and detentions of at least 24 Nubian protesters, has the honor to attach herewith a list of names of all persons charged in the aforementioned case, as provided by the Ministry of Justice.
