Zhen Jianghua is a 32-year-old male. On 1 September 2017, the Guangdong Province public security authorities placed him in criminal detention, in accordance with the law, on suspicion of instigating subversion of the political power of the State. On 29 September the coercive measures were converted to house arrest in a designated residence. The case is currently pending and is under investigation.
