REPLY OF VIET NAM TO THE COMMUNICATION

Ref. UA VNM 10/2018 (dated 05 November 2018)

1. On the conditions of detention of Tran Thi Nga

Tran Thi Nga committed the offence of "conducting propaganda against the Socialist Republic of Viet Nam" under Article 88 of the Criminal Code of 1999. She was arrested on 21 January 2017 and tried on 25 July 2017. Her appeal was heard on 22 December 2017. She was sentenced to 09 years imprisonment.

Tran Thi Nga started serving her sentence at Gia Trung Prison, Gia Lai Province since 27 February 2018 and shared her room with two other inmates, namely

These two prisoners are classified as having good behaviors, for which sentence had been commuted 3 times, a total of 22 months and finished serving her sentence in February 2019.


Since serving her sentence at Gia Trung prison, Tran Thi Nga frequently refused to obey the orders of the prison officials, not wearing prison clothes, instead using those ordinary clothes that she brought from outside, whereas refused to let the prison officials to stamp the prison stamp on those clothes, which is a violation of the detention regulations. Moreover, she did not participate in working or vocational training, regularly use bad, dirty words to insult prison officials and the authority, disturbed the prison order and thus violated the prison regulations.

Though prison officials had had several talks with her and other prisoners had tried to advise and encourage her to obey the prison regulations, she refused to follow any advices and continued to insult the prison officials and other inmates. On 23 July 2018, she was disciplined in the form of a warning for not complying with prison officials' orders, causing disorder and insulting officials as well as other prisoners.

For the fact that Tran Thi Nga's acts disturbed other prisoners' life and activities, on 28 July 2018, she was moved to another room but still in the same bloc, which could not be considered as incommunicado detention. Every day, she receives meals provided by the prison and can still buy additional food if she wants at the canteen. On 15 November 2018, she was checked up by a prison doctor and was found to be in normal health.

2. On family visits


Gia Trung Prison has organized family visits in accordance with national laws and regulations. However, Tran Thi Nga refused to comply with the regulations on family visits. In particular, she did not wear prison clothes nor allow the prison officials to stamp on her ordinary clothes, which is in violation of Article 6, paragraph 2 of the Circular No. 07/2018/TT-BCA dated 12 February 2018 on prisoners' family visits, sending and receiving letters, receiving personal supplies and money, and phone calls to family members.



On 17 November 2018, visited her again. This time, she wore the prison clothes and obeyed the rules on family visits. was not allowed to visit Nga as he was unable to present any paper which proves his relationship with Tran Thi Nga.

3. On family phone calls and supplies

Gia Trung Prison allowed Tran Thi Nga to make phone calls to and receiving their supplies in accordance with national laws and regulations, in particular Articles 46 and 47 of the Law on the Enforcement of Criminal Sentences, Articles 9 and 13 of the Circular no. 07/2018/TT-BCA dated 12 February 2018 on prisoners' family visits, sending and receiving letters,



- She talked to 2 times via the phone number on 25 September and 22 October 2018.
 - She received 06 books from on 15 June 2018.
- She received tea, mushrooms and lotus seeds from on 08 September 2018.
- She met on 09 June 2018 and received from him Dried jackfruit, dried beef, dried fish, slippers, coffee, boiled chicken and
- She met on 26 July 2018 and received from him an antichapping cream, a facial cleanser, a women hygiene liquid, a vegetarian bologna, fresh lemons, dried mushrooms, peanuts and brown rice.
- She met on 22 August 2018 and received from him longan, a dietary supplement used for improving blood circulation, jujubes, Pía cakes, coconut candies and biscuits.
- She met on 17 November 2018 and received from him oranges, milk, bread and candies.

In conclusion, the conditions of detention and treatment of Tran Thi Nga have met the standards required by the national laws and regulations and been in line with Viet Nam's international obligations.
