Receipt is hereby acknowledged of urgent communication UA CHN 10/2019 dated 28 May 2019 from the United Nations Human Rights Council's Special Rapporteur on the situation of human rights in the Democratic People's Republic of Korea. The Chinese Government wishes to submit the following response:

People from the Democratic People's Republic of Korea who illegally enter China for economic reasons are not refugees. They have come to China through illegal channels and in violation of Chinese law, and they have undermined the country's orderly management of entry and exiting over its border. Regarding the question of illegal entry by people from the Democratic People's Republic of Korea, China adheres to a principle combining domestic law, international law and humanitarian considerations. The Chinese police in Liaoning Province recently apprehended two persons from the Democratic People's Republic of Korea who had illegally entered the country. Following Chinese law, the public security agency detained the two persons for investigation, in accordance with the law. China will, in accordance with the law, deal with the above case in the appropriate manner, guaranteeing the legal rights of the persons concerned to the greatest extent possible.
