Receipt is hereby acknowledged of joint urgent appeal UA CH9/2019 dated 20 May 2019 from the Working Group on Arbitrary Detention, the Working Group on Enforced or Involuntary Disappearances, the Special Rapporteur on extrajudicial, summary or arbitrary executions, the Special Rapporteur on the promotion and protection of the right to freedom of opinion and expression, the Special Rapporteur on the situation of human rights defenders and the Special Rapporteur on extreme poverty and human rights, of the United Nations Human Rights Council. The Chinese Government wishes to submit the following response:

Jiang Tianyong, a 48-year-old male born in 1971 in Luoshan county, in the Xinyang municipality of Henan Province, was sentenced to 2 years of prison and stripped of his political rights for 3 years on 21 November 2017 for instigating subversion of the political power of the State. On 28 February 2019 he completed his sentence and was released. He is currently serving the period of deprivation of his political rights.
