In case of regular households the Application for inclusion in NRC shall be made by the head of the family detailing particulars of all family members. In case of institutional homes such as orphanages, old age homes, asylums etc, the responsibility of providing requisite details of the inmates shall lie with the head of the institutions.

The Application Form shall have particulars recorded for all individual members of the family. Each Form has the provision of capturing details up to 6 (six) members of the family. In case a family has more than 6 (six) members, additional Forms shall be used.

The same order of Member Serial No written on the first page, Side A, shall be followed throughout in all 4 (four) pages of the Form. The same shall be maintained in case of Additional Forms used by families having more than 6 (six) members.

### Side A:

Instructions and codes for filling up Q. 1a, Q. 2a, Q. 2b, Q. 2c, Q. 3a, Q. 4a, Q. 4b & Q. 4c are given at the bottom of the page.

### Side B

Individual members shall furnish location particulars related to (1) Present Address (2) Permanent address and (3) Place of birth. Addresses shall be written as per format indicated in the spaces marked in the Application Form. If the permanent address is same with the present address of individual member, then can write only "same" in the space provided for Q.7. Place of birth shall be written in full by all members. Duration of stay in the present address in years as on 1<sup>st</sup> April 2015 shall also be furnished under Q.6b.

Only recent colour photograph of the size 2.5 cm x 2.5 cm shall be accepted. The photograph should be pasted properly using good quality glue. In any case, staple or pin should not be used.

### Side C

Any one of the three questions Q.9 or Q.10 or Q.11 is sufficient. The particulars entered in this page shall be supported with documentary proof enclosed with the Form. Documents in support of Q.9a & Q.9b, Q.10a & Q.10b and Q.11a & Q.11b shall be selected from List A (any one is sufficient) placed at the bottom of the page, which should be of any years upto 24<sup>th</sup> March 1971, and the documents in support of Q.9c & Q.9d, Q.10c & Q.10d and Q.11c & Q.11d shall be selected from List B (any one is sufficient) placed at the bottom of the page, and shall also be accepted if issued before or after 24<sup>th</sup> March 1971.

### Side D

Q. 12a and Q. 12b shall be applicable to people who stayed in any place other than the state of Assam upto 24th March (Midnight), 1971. Persons who are originally inhabitants of Assam and their children and descendants who are citizens of India staying in place other than the state of Assam upto 24th March (Midnight), 1971 may give their particulars here.
