According to the submitted documents, the following violations exist.

The previously mentioned remarks in Order No. 24 dated January 9, 2018, according to which it was necessary to bring the goals of the foundation into line with Article 4 of the Law of the Republic of Kazakhstan on “Non-Profit Organisations”, have not been eliminated

According to the submitted documents there are the following violations.

It is necessary to harmonise the goals of the fund in accordance with Article 4 of the Law of the Republic of Kazakhstan "On Non-Profit Organisations", according to which non-profit organisations can be created to achieve social, cultural, scientific, educational, charitable, and managerial goals; protecting the rights and legitimate interests of citizens and organizations; dispute and conflict resolution; meet the spiritual and other needs of citizens; protecting the health of citizens, environmental protection, the development of physical education and sports; providing legal assistance, as well as for other purposes aimed at providing public goods and the benefits of its members (participants).

Guided by Article 9 of the Law of the Republic of Kazakhstan “On state registration of legal entities and accounting registration of branches and representative offices”, I ORDER TO:

1. Interrupt the state registration of the “KAZAKHSTAN FEMINIST INITIATIVE “FEMINITA” Public Fund;
