	<p>County Councils¹¹</p> <p>Relevant attributions:</p> <ul style="list-style-type: none"> - attributions regarding the establishment, organization and functioning of the specialized apparatus of the county council, of the public institutions of county interest and of the companies and autonomous utilities of county interest; - attributions regarding the economic- social development of the county; - attributions regarding the administration of the public and private domain of the county; - attributions regarding the management and financing of public services of county interest (including DGASPCs); - responsibilities for interinstitutional cooperation at internal and external level;
<p>Monitoring Council regarding the implementation of the CRPD¹²</p> <p>Relevant attributions:</p> <ul style="list-style-type: none"> - examine regularly respecting the exercise of the rights of persons with disabilities in residential institutions; - make recommendations on the compliance of the rights of persons with disabilities in residential institutions and monitors their implementation - immediately notifies the competent judicial bodies whenever there are indications that the violation of the rights of persons with disabilities was committed by acts of a criminal nature and may file a complaint, if necessary; - notifies the legally competent authority to order disciplinary or contravention sanctions or to suspend, withdraw and cancel the accreditation of residential institutions, in
