Reply of the Government of Iraq to the joint communiqué regarding the journalist Sherwan Amin Naao Suleiman

- 1. The full name of the individual in question is Sherwan Amin Naao Suleiman. On the basis of probatory evidence, an arrest warrant was issued against him by the investigating judge on 6 October 2020 and he was arrested on 7 October 2020 under article 1 of the Criminal Code of the Kurdistan Region Iraq.
- 2. He was charged under article 1 of the Criminal Code of the Kurdistan Region (Act No. 21 of 2003), which stipulates: "Anyone who, in any manner, deliberately commits an act with the intent to prejudice the security, stability and sovereignty of the institutions of the Kurdistan Region Iraq, and which produces the intended effect, shall be liable to imprisonment for life or for a fixed term."
- 3. The accused person made his statement before the investigating judge on 8 October 2020, in the presence of a lawyer appointed by the Office of the Public Prosecution. The accused person then examined and signed the record without being subjected to any form of coercion.
- 4. The individual concerned was not held in solitary confinement; however he was isolated in a special unit for a brief period as a preventive measure. This is in line with a health protocol which has been followed since March 2020 and which is intended to ensure that new detainees are not carrying the novel coronavirus (2019-nCoV).
- 5. He was visited by the Red Cross on 22 October 2020 and has had telephone calls with his family.
- 6. Investigations are still ongoing at and under the supervision of the Court of Appeal in Erbil, and a ruling will be handed down only after all legal procedures have been completed. It should be pointed out that proceedings are taking place in full respect of legal formalities and of the international obligations of Iraq.

- 2- التهمـة المسـندة اليـه هـي وفقاً للمـادة الاولـي مـن قانون عقوبات اقلـيم كريسـتان رقم 21 لمنة 2003، والتربي تناص على انده: (يعاقب بالسجن المؤبد او المؤقت من اربتكب عمداً فعل بقصد المساس بأمن واستقرار وسيادة مؤسسات اقليم كردستان - العراق بأية كيفية كانت وكان من شأنه ان يؤدى الى ذلك).
- 3- بتاريخ 2020/10/8 ادلي المستهم بافادته امسام قاضي التحقيق وحضر الجلسة محام مكلف وممثل عن مكتب الادعاء العام، ووقع المحضر بعد الاطلاع عليه ودون اي اكراه.
- 4- لم يتم حجز المشار اليه في وحدة انفرادية كما ذكر، وانما جرى عزله في وحدة خاصة ولفترة قصيرة كأجراء وقائي استنادا الي البروتوكول الصحي المتبع منذ مارس 2020، للتاكد من ان المحتجزين الجدد لسيوا حاملين لفابروس كورونا المستجد (كوفيد -19).
- 5- تمت زيارته من قبل لجنة الصليب الاحمر في 2020/10/22، اضافة الى اجرائه مكالمات هاتفيه مع عائلته.
- 6- لازالت التحقيقات جارية في محكمة استئناف اربيل وتحت اشرافها وسيصدر الحكيم بحقيه بمجرد انتهاء الاجراءات القانونية، مبع التاكيد على اتخاذ الاجراءات وفقاً للشكل القانوني واحترام التزامات العراق الدولية.
