Information from the National Police of Ukraine in response to the request of the United Nations Human Rights Council's special procedures for information regarding the citizens of Uzbekistan, A. Gaidarov and R. Saparov

A verification by the Criminal Investigation Department of the National Police has established that on 14 April 2017, R. Saparov was sentenced by the Desnianskiy District Court of Kyiv to up to 4 years and 6 months of deprivation of liberty for committing a crime covered by article 186 (2) (robbery) of the Ukrainian Criminal Code.

As for Uzbek citizen A. Gaidarov, according to the Information Portal of the National Police of Ukraine, an information and telecommunication system, he is listed as a missing person.

On this matter, on 5 October 2020 the Mikolayiv Province investigative department of the central police department under the Main Directorate of the National Police opened a pretrial investigation, in separate criminal proceedings. Information on the proceedings was entered into the Single Registry of pretrial proceedings for criminal offences, as provided by article 115 (1) (murder) of the Criminal Code of Ukraine.

In addition, according to information from the Department of International Police Cooperation of the National Police of Ukraine, as at 7 December 2020, persons with the particulars of Alisher Haydarov and Rahmiddin Saparov were not listed by the General Secretariat of INTERPOL, the International Criminal Police Organization.

It was also established that on 5 August 2019 a written application was filed with the Department of International Police Cooperation of the National Police of Ukraine, from the INTERPOL National Central Bureau in Uzbekistan, regarding Uzbek citizen R. Saparov, who at the time was wanted by the law enforcement agencies of Uzbekistan for crimes covered by article 223 (illegal exit or entry over the national border) and article 244-2 (establishment, leadership or participation in religious extremist, separatist, fundamentalist or other prohibited organizations) of the Criminal Code of Uzbekistan. The initiator of the request applied for assistance for Mr. Saparov's deportation/transfer to the law enforcement agencies of Uzbekistan, through the National Security Service of Ukraine.

The request was forwarded to the National Security Service of Ukraine for further consideration on 14 August 2019.
