The Permanent Mission of the Kingdom of Cambodia to the United Nations Office and other International Organisations at Geneva presents its compliments to the Office of the United Nations High Commissioner for Human Rights (OHCHR) and, with reference to the latter's communication No. WGAD/KHM/ 2020/CASE/1 dated 24 September 2020, has the honour to transmit to the OHCHR herewith reply from the Ministry of Interior and Cambodian Human Rights Committee with regard to the alleged arbitrary deprivation of liberty of Mr. Osman Karaca as follows:

- 1- The case of Mr. Osman Karaca was not arbitrary deprivation of liberty, but enforcement of Law on Immigration of the Kingdom of Cambodia as to deportation of foreigners from its territory and definitive ban of re-entry into Cambodia.
- 2- It is cooperation in criminal matters with other countries in preventing and suppressing transnational crimes.
