Regarding Mr. Heidar Qorbani

With respect to the Special Procedures Mandate-Holders' urgent appeal appertaining to **Heidar Qorbani**, the following points as received by the Provincial Justice Branch of Kurdestan are provided here for further clarification:

- 1. The aforesaid has been convicted as guilty because of committing serious crimes by assassinating several persons through several terrorist operations with two terrorist teams affiliated to terrorists group of Komala. We mentioned already in our previous communications that he himself also confirmed in his remarks (without any pressure or coercion) that he went to Iraq and made acquaintance with one of the agents of this terrorist group and he returned to the country. He said the agent called him in August 2016 and informed him of the plan and together they committed these serious crimes.
- 2. Allegations mentioning the issuance of death penalty based on forced confessions are devoid of any standing. The verdict issued during the trial based upon corroborating evidences which exist in his file and not only because of his own remarks.
- 3. The aforesaid went into hiding at his place of domicile following the committing of the crime. He was arrested by the police, indicted and informed of his right to counsel immediately. The aforesaid has enjoyed due process of law and having access to attorney and legal representation since his arrest. In line with transparency, his trial sessions have been held openly and the whole trial process has been recorded which is available in his file at the Court.

4. Nearly 95 per cent of people residing in Kurdestan province are Iranian Sunni citizens speaking Kurdish language. Moreover, it is important to be noted that a considerable number of judges in Kurdestan Provincial Justice Branch are from the same province which consists of Sunni Kurd citizens. Therefore, allegations about lack of impartiality in the judicial process because of the convict's minority status is null and void.
