**JOINT COMMUNICATION AL BRA 2/2022, DATED
FEBRUARY 18TH 2022.**

**ADDITIONAL INFORMATION FROM THE GOVERNMENT
OF BRAZIL**

With regard to the joint communication AL BRA 2/2022, dated February 18th 2022, regarding Ms. Alessandra Korap Munduruku, the Government of Brazil has the honor to convey the following additional information.

According to the National Secretariat for Comprehensive Protection (SNPG), under the Ministry for Women, Family and Human Rights (MMFDH), the case of Mrs Alessandra Korap Munduruku is now being followed by the Protection Program for Human Rights Defenders, Communicators and Environmentalists (PPDDH) of the State of Pará (PA) in northern Brazil.

The PPDDH/Pará has informed that the assisted person is being monitored and that coordination measures were taken involving the State Secretariat for Public Security and Social Defense of the State of Pará (SEGUP/PA), in addition to the federal government bodies, such as the Ministry of Justice and Public Security (MJSP), the Federal Police (PF) and its Regional Office in the State of Pará, the National Foundation for Indigenous Peoples (FUNAI), the Health Secretariat of the State of Pará (SESPA) and the Brazilian Environmental Institute (IBAMA).

The competent authorities are committed to the appropriate emergency measures taken to safeguard Ms Alessandra Munduruku's life, physical integrity and safety.
