





<p>1. Abduction bid by fake [redacted] foiled</p>	 <p>Locals vandalizing a microbus near the capital's [redacted] area on [redacted]. Some unidentified impersonating [redacted] members kidnapped a man and were taking him away in the vehicle. However, the locals stopped it and rescued the victim after he screamed for help. The rescuers then damaged the microbus, but the criminals managed to escape.</p>  <p>A walkie-talkie and handcuffs found on the scene.</p>	<p>Locals vandalizing a microbus on [redacted] foiled an attempted abduction by four people who identified themselves as detectives and tried to whisk a man in a microbus at [redacted] in the [redacted].</p> <p>The criminals equipped with handcuffs and a walkie-talkie forced a [redacted] into the vehicle around [redacted] on [redacted] near [redacted] intersection, soon after [redacted] had come out of a bank withdrawing around BDT 7 lakh, police said, quoting witnesses.</p> <p>As the victim cried for help and started kicking on the window glasses of the vehicle in a desperate effort to get free, locals started chasing the microbus, which got stuck in traffic several hundred metres away.</p>

Fake police arrested</p>		<p>[redacted] have arrested a fake police officer named [redacted] was arrested from the police station area around [redacted].</p> <p>[redacted] Police Station Officer-in-Charge (OC) [redacted] said [redacted] had been introducing [redacted] as a police officer in the area for a long time. Someone told [redacted] was an employee of the intelligence agency. [redacted] introduced [redacted] to the police as an [redacted] employee. To confirm [redacted] identity to the general public, [redacted] sometimes carried a gun, sometimes wore a police uniform, and sometimes posted pictures on his Facebook page. 4.	Fake policemen arrested for taking bribe in [REDACTED]		<p>Locals in [REDACTED] arrested two fake policemen on [REDACTED]. They identified themselves as [REDACTED] Detective Branch ([REDACTED]) police when they came to [REDACTED] to take bribe.</p> <p>[REDACTED]</p> <p>[REDACTED] confirmed the arrest of a fake [REDACTED] police [REDACTED]</p> <p>The victim [REDACTED] said, 'I met them on my way home after completing the written test for the post of constable in [REDACTED] Police Lines a few days ago. They took pictures of my written exam papers and other information papers. After coming home, they demanded BDT 30,000 on my mobile phone with the guarantee of my job. I told [REDACTED] to come home to get the money. My [REDACTED] and the locals informed the police if their conversation seemed suspicious.'</p>
5.	Two members of fake police arrested in [REDACTED]	 <p>[REDACTED] fake police [REDACTED] snatched Tk 1.8.530 from a [REDACTED] trader in the identity of [REDACTED] Police in [REDACTED]. The incident took place on [REDACTED] at the [REDACTED] area of the upazila.</p>	<p>[REDACTED] in the affected [REDACTED] trader's upazila, said that [REDACTED] had taken [REDACTED]. [REDACTED] was identified by the [REDACTED] Police Investigation [REDACTED]</p> <p>[REDACTED] said that after that [REDACTED] started fighting with handcuffs as [REDACTED] had phencidyl.</p> <p>[REDACTED] said that at that time the trader had snatched 1 lakh 8 thousand 530 BDT in cash. At one point, the [REDACTED] broke his handcuffs and started shouting. At that time the locals came forward and arrested two of them but they fled with the money.</p> <p>After receiving the news, the police arrested two fake police [REDACTED] from the spot and brought them to the police</p>

6.	<p>Fraud in the name of [REDACTED] one of the arrests</p>		<p>station. Police Officer-in-Charge [REDACTED] admitted the incident and said the names and addresses of the detainees were being verified.</p> <p>The Detective Branch of [REDACTED] Metropolitan Police [REDACTED] has arrested a fraudster from [REDACTED] area of the [REDACTED] on the charge of being involved in various criminal activities in the name of [REDACTED]. The name of the arrested is [REDACTED].</p> <p>[REDACTED] the organized crime and car theft prevention team arrested [REDACTED] from [REDACTED] area of [REDACTED] police station.</p> <p>[REDACTED] Assistant Commissioner of Police, [REDACTED] said that a fake [REDACTED] Police Station, was staying at a house in [REDACTED] East Sheorapara, and was carrying out various criminal activities. The house was raided on the basis of such information. One person was arrested while members of the fraud ring were fleeing after sensing the presence of police. After [REDACTED] arrest, 1 pistol-like metallic lighter, 2 pistol covers, 9 ATM cards of different banks, 30 visiting cards of a fake [REDACTED] and a mobile phone were recovered from his custody.</p> <p>Regarding the information obtained during the preliminary interrogation, [REDACTED] said that the arrested [REDACTED] used to make fake visiting cards and arrest drug dealers under the guise of [REDACTED] and extort money by showing fear of lawsuits. [REDACTED] used to extort large sums of money from the [REDACTED] by showing the temptation of [REDACTED] by having relations with the [REDACTED] of an [REDACTED] family, including collecting money from both the parties for resolving the dispute over the disputed land and flat. The [REDACTED] did not pay for the purchase of refrigerators, TVs and other daily necessities from various shops.</p>

7.	<p>Fake police arrested during extortion in [REDACTED] handed over to police</p>		<p>Local businessmen have arrested a fake member of police while extorting money from hawkers and traders in [REDACTED] was later handed over to the police with good medium. [REDACTED] was arrested from [REDACTED] area of the [REDACTED] Police Station [REDACTED] said this on [REDACTED].</p> <p>The name of the arrested is [REDACTED] of [REDACTED] police station of [REDACTED] area of [REDACTED].</p> <p>The police officials and local traders said that for the past few months, [REDACTED] and some of [REDACTED] accomplices had been collecting extortion money from various hawkers and traders including fruit sellers in [REDACTED] area under [REDACTED] police station.</p> <p>On [REDACTED] they demanded BDT 5,000 from a fruit seller Ratan. If the trader suspects their behavior, [REDACTED] refuses to pay. [REDACTED] took a toy pistol out of his pocket for fear of being shot. At that moment, the traders of the area chased [REDACTED] and arrested [REDACTED].</p> <p>The [REDACTED] further said that [REDACTED] accomplices fled during the incident. The detainee was later handed over to the police through good means. A toy pistol, a laser light, a pair of police shoes, BDT 2,500 in extortion money, a mobile phone and 20 visiting cards were seized from [REDACTED]. A case has been filed in the police station in this incident of extortion under false identity.</p>
